

Rules to live in your home



You live in a LWB house



You signed lots of papers to live in your home.

It means you agree to our rules.



You must follow these rules

Pay your rent on time



Put home and living in your NDIS plan.

It pays some of your rent.



You live in your home.

You can not run a business from your home.



Every one must feel safe at home.



You knock on some ones bedroom door.

You do it again and again.

The other person does not want to talk to you.

Do not knock on their door all the time




You must be quiet in your home.

Like do not play very loud music all the time.



Lots of different people come to your home. Like

- staff who help you
- staff for your house mate
- LWB staff
- workmen.



Be nice to all staff. Like

- do not be rude to them
- do not swear at them.



Tell LWB when you

- go on holidays
- you are away from your home for a long time.
- Like 2 weeks.



Look after your home. Do not break things in your home. Like do not punch a hole in the wall.



There are rules about when you move out.



The rules tell you

- what to do
- when you need to tell LWB

About your rent



You need money for rent in your NDIS plan.

It needs to be in your plan each year.



You pay rent.

You do not pay other money.

You do not pay a bond when you move in.



You pay some of the rent.

and



The NDIS pay some too.

How much rent do you pay?





We work out your rent from the money you get.

We check

• your NDIS money to rent a house

and



• your money from Centrelink.

You may get



- Youth Allowance
- Disability Support Pension.

We write **pension** to talk about it.



You pay only some of your pension for rent. Like you get \$ 200 each week. You pay \$ 50 each week for rent.




You may get other money from Centrelink. Like Help to Rent money. It is for your rent too.



You may not get a pension. That is OK.



There are rules about how much you pay. It is the same as a person on the pension.




LWB can give you a record of your rent.

It will tell you how much rent you pay

- from your pension
- from your NDIS plan.

You want to move out



You can move to a different home.

With LWB

or

With another Housing Provider



We work with

• you

• your family



and

- the staff that work with you
- other people that help you



We try our best to find a home that works for you.

Why can you move?





You are in danger. Like your house mate

• kicks you.



• does the wrong thing.

Like steals from you.



You argue with a house mate.

You can **not** fix the problem.



You may have a problem with the house. Like



the house is not right for your disability. Like
it is hard for you to walk.
There are stairs at the back door.
You can not get in your back door

or



• too many people live in your home now.

There may be lots of noise.

You like a quiet home


or



• you get very sick. Your needs change.



Like you need staff to be awake all night.



It is ok for you to move.

You want to move out





You must tell us 2 months before this. It is the same as 60 days. Like you want to move out on 30 July. You must tell us by 30 May.



You must write a letter to tell us.

Tell us the date you will move out.

You must pay all your rent.

You pay up to the day you move out.


We ask you to move out. What do you do?



Why can we tell you to move out?



1. LWB have a new home for you.



or

2. You need a home that is better for your needs.

Like you are deaf.

You need smoke alarms you can see.

They are in your new home.



You do not need the same help. Like
 You did use a wheel chair.

but



You can walk now.



You can use the stairs.

You do not need a ramp at the door.

or



4. Your home can not be used for a person with a disability now.



We tell you to move out



We make a time to meet you.

You can have other people come.

Like

- your mum
- a carer.



Other people at the meeting may be

- a person who looks after your staff.
- other people that help you





We work with you to find out what you need.


Like you need

• a person to help you clean




• different staff in your home.


Like staff who know how to use Auslan.

The best thing for you is to find a new home.





LWB must tell you 3 months before you must move out. This is the same as 90 days. Like LWB need you to move out on the 30 April. LWB must tell you by 30 January.



We must help you find a new place to live.

Like your home has 2 bed rooms




• LWB will help you find a new home

for your home.




You may need to go now



We write you a letter.


It says you must move out now.

You kick holes in the walls.



It may be


• you hurt your house mates. They are in danger.

You must take all your things. Like


- your bed

When you moved in the curtains were clean.


Now the curtains are clean too.

Did you break things in the home? Like


• you kicked a wall



• broke a window.




You will pay to fix it.



You said you will move out.


You set the day. Like Friday 20 November.

but




You still pay rent to the end.

You need a new house mate




You have a house mate.


They move out.




There is an empty room in your home.

LWB will search for a new house mate.




LWB work with the staff in your home.

You need some thing fixed




Some thing breaks.

LWB need to fix it.




Are the house staff from LWB?






Something needs to be fixed now.

You must tell the house staff now.




Like it is night time. It needs to be fixed now.

and




• who will do it.

• no. You can not make the change.




LWB do not pay for this work.

The wall broke.




You may need to pay some money.




LWB will meet with you. We will talk about

and




We work with NDIS.
